**60/2017**      **Digital Connectivity / GDPR / E-Gaming Presentation** – Callie Loveridge-Newey, Deputy Joe Mooney & Emma Martins in attendance.

**Digital Connectivity** – The Committee noted the progress with improving the digital connectivity and further that the telecoms companies of JT and Sure would be presenting proposals shortly to the Chief Information Officer (CIO) to outline how they would propose delivering improved connectivity for business and private customers. It was further noted that the CIO would provide a report for the Committee to consider at its next meeting once more information was available on the options which were being offered.

**Shipping – Passenger & Freight Service – Way Forward** – Report from James Dent dated 8<sup>th</sup> May 2017 tabled and noted.

**The Policy and Finance Committee agreed to:-**

- 1. Support the Marine Transport Working Group (MTWG) in seeking expressions of interest from private sector operators for providing a passenger/freight sea service ahead of a commencement date of 1<sup>st</sup> January 2018, based on financial support of up to a maximum of £100,000 per annum on production of a full business case, from the States of Alderney’s Economic Development Fund.**
- 2. Seek legal advice from St James Chambers on the details of Condor’s arrangement before inviting expressions of interest.**
- 3. The MTWG to report back to the Committee on the outcome of its discussions on the matter.**
- 4. Not proceed with a visit to view the Sea Rex (Mr Jean, Mr Roberts & Mr McKinley against).**
- 5. Tenders for the new passenger/freight service will be sought in 2017 ahead of a commencement date of 1<sup>st</sup> January 2018.**

**65.1 Monitoring the Direct Contribution of Alderney e-Gaming Industry to the Bailiwick of Guernsey** – Report from Economic Development Officer dated 2<sup>nd</sup> May 2017 tabled and noted.

The Policy & Finance Committee noted that there were different reports into the level of economic contribution being achieved in both Alderney and Guernsey from licensed e-gaming, and agreed that the officers of both islands liaise to address any differences in the underlying assumptions. Furthermore, it was agreed to accept the formula set out in the briefing paper and that for ease of understanding, future reporting would use the four quarters each calendar year, with the expectation that the resultant data would be available in mid-May annually.
