**ACTION****70/2017****Matters Arising****70.1 Committee feedback from Chairmen (B&DCC, GSC & Transport & Tourism) & Guernsey Representatives**

**BDCC** - The Committee noted a verbal update from the Deputy Chairman of BDCC, covering a range of matters including the open meetings, progress of the LUP and revisions to legislation.

**GSC** – The Committee noted a verbal update from the Chairman of GSC, covering a range of matters including taxi fares and night cover, the skate park, small vessels code, the waste burner, sand extraction and the future options for the scramble track.

**Transport** – The Committee noted a verbal update from the Committee Chairman regarding:-

- a) The progress being by Air Alderney to secure its application for an Air Operators Certificate (AOC); and
- b) The recent decision by the Jersey & Guernsey authorities not to subsidise an inter-island passenger ferry service. The Committee also agreed to contact the Guernsey & Jersey authorities to affirm Alderney's interest in securing an effective inter-island passenger service and the willingness to provide a measure of financial subsidy.

**Tourism** – The Committee noted a verbal update from Tourism lead on various matters including the recent visit of the Victor Hugo with multiple passengers from France, and the positive joint working between Visit Alderney & Visit Guernsey.

**Education** – The Committee noted that the Vice President of the Guernsey Committee for Education, Sport & Culture and the Director of Education had recently visited Alderney. Their attention had been drawn to local concerns and in response, had provided assurances and planned further visits to Alderney in July. It was further agreed that the Chairman of P&F and the States representative on the School Committee would liaise with the Head Teacher with a view to periodic updates being provided to States Members.

**Guernsey Representatives** – nothing further to report.

**70.2 Aurigny Review Update** – Report from the Chief Executive dated 31<sup>st</sup> May 2017, Aurigny Strategic Review Report and the Aurigny Strategic Review Panel Report tabled and noted.

**The Committee noted the update from the Chairman on the recent Aurigny Review and resolved to:-**

- Urge the States of Guernsey to publish immediately the Aurigny Review Reports; and
- Support the call for the Bailiwick air links to be seen primarily as economic enablers and also as social enablers;
- Call for discussions on the nature of the Public Service Agreement that would best serve Alderney and the Bailiwick;
- Ask members to consider what appropriate questions could be raised on the matter by the Alderney representatives in the States of Deliberation, and advise the members accordingly.

The Committee also resolved to advise CH&SC of the ongoing concerns that many of the issues arising out of the Wilson Review remained to be addressed particularly in relation to primary health care.

**72.1 Interpretation and Standard Provisions (Bailiwick of Guernsey) Law, 2016** – Report from Chief Executive dated 31<sup>st</sup> May 2017 tabled and noted.

**73/2017 Budgetary, Financial & Employment Matters**

**73.1 Aviation Fuelling Update** – Report from Strategic Financial Adviser dated 6<sup>th</sup> June 2017 tabled and noted.

**The Policy & Finance Committee resolved to:-**

- **Support the subsidy of up to £90k to AEL to continue to provide AvGas and Jet A1 through until September, to be charged to the economic development fund and for this to be implemented as a matter of priority; and**
- **Agree such capital costs up to £100k as necessary to facilitate this work, to be charged to the capital account,**
- **Encourage AEL to supply the fuel at the lowest practical cost; and**
- **Seek a long term solution which will secure the supply of both types of fuels, through engagement with AEL and through an open tender process. The tender process to allow for self-service fuelling of AvGas is to be included as one of the options.**

**73.2 Swimming Pool Update** – Report from Chairman of Finance Committee dated 6<sup>th</sup> June 2017 tabled and noted.

**The Policy & Finance Committee agreed:-**

- **To note the latest position;**
- **That this matter should be shared informally with the States of Guernsey at political level when more detailed costings of the options have been obtained, to establish whether there is any merit in considering additional funding at this stage; and**
- **To ask ACSC to revise the figures in the operational business plan to enable detailed scrutiny by the States to manage potential future risk.**

**73.3 CE Recruitment Update** – Report from Chief Executive dated 31<sup>th</sup> May 2017 tabled and noted.

**The Policy & Finance Committee approved the expenditure of up to £25,000 for costs associated with the recruitment of the next Chief Executive to be charged to the P&F Committee & Sundry Expenses (Revenue Account) Budget.**

**The Policy & Finance Committee agreed that its members use whatever opportunities arise to encourage banking institutions serving Alderney to allow small businesses to open trading accounts and keep the fees for counter services at an affordable level.**
