**\* Please Note:**

**1. Section 62(5) of the Government of Alderney Law, 2004 (as amended) states**

**“ For the purposes of this Law –**

- (a) a person shall be considered to be ordinarily resident in Alderney in any year if and only if he is in the Island for an aggregate of not less than 273 days during that year,**
- (b) Notwithstanding the provisions of paragraph (a), a person does not cease to be ordinarily resident in Alderney during any period by reason of the fact that during that period –**
  - (i) he is engaged, elsewhere than in Alderney, in full-time education or training at an establishment which is, or which is comparable to, a university, college or school, or**
  - (ii) he is serving, elsewhere than in Alderney, in the armed forces of the Crown or in the Merchant Marine. “**

**2. You may be requested to provide written proof of residency and/or age. Please be assured that this information will **not** be included on copies of the Electoral Roll made available for inspection, nor will it be disclosed to any other person.**
